Short biography: *Born in 1972 (Budapest, Hungary). He is a Hungarian canon lawyer and medievalist university professor, awarded with Széchenyi-prize, full member of the Academia Europaea (London). Best known for his work in paleographical and codicological research on the original pre-Gratian manuscripts, 'work in progress' theory regarding canonical collections between the 8th and 12th century; and historical development of relationship between Church and state. He is invited lecturer of several European, USA, South American, West Asian, Middle Eastern and Far Eastern universities, as well as being a leader or participant in several international scientific research programs. In his research field he is a highly cited researcher with more than 900 registered international scientific publications.*
